Sub: Contempt Notice for violation of the orders dt.28.2.2024 in
W.P.No.36043/2021 passed by the Hon’ble High Court of
Telangana- Reg.

1. On instructions of my client Sri Gangavarapu Anjaneya Reddy, S/o.late G.Koti Reddy, Aged:45 years, Occ:Self Employment, R/o.Flat No. G06, Block C, Floatilla, Neknampur Road, Alkapoor Township, Manikonda, Hyderabad-500089, this contempt notice calling upon you to forthwith implement orders dt.28.2.2024 in W.P.No.36043/2021 passed by the Hon’ble High Court of Telangana.

2. My client is the absolute owner and possessor of agricultural land admeasuring Ac.14.07 gts situated in Sy.No.89, 90, 91, 92, 95 and 96 of Obugunta Village, Shabad Mandal, Ranga Reddy District having purchased the said land for valuable sale consideration under registered sale deed vide document No.4831/2015 dt.6.8.2015.

3. A public road is passing through Sy.No.12/1, 12/2 & 12/3 of Obugunta Village, Shabad Mandal, Ranga Reddy District, which is the only source of ingress and egress to my client’s agricultural lands. The said road is being

used for agricultural purposes from the time immemorial. This road is being visible in Google Maps and also evidently shown in the Village Map and also in the IGRS Website.

4. While so, some unscrupulous persons for vested interests and with a mala-fide intention to extract money from the persons, including my client, who are having lands along the said road, damaged the said public road and illegally blocked the same.

5. As per the TS Panchayatraj Act, 1994, all the roads situated in the Grampanchayat are vested in the Grampanchayat and the authorities concerned have all the rights and duty to maintain the said roads and to ensure that the said road should not be blocked or damaged by any persons. If any persons block such roads for legal requirements, the Grampanchayat has to collect the appropriate fee from the said persons and restore the road.

6. Though, the said road was damaged and blocked by some unscrupulous persons in the year 2020, Grampanchayat did not take action on those unscrupulous persons and did not restore the said road for the reasons best known, thereby, all the persons, including my client, who are using the said road for agricultural operations are put to sufferance and they are facing several difficulties in conducting their agricultural operations.

7. Therefore, my client made a representation dt.23.10.2020 requesting you to restore the public road passing through Sy.No.12/1, 12/2 & 12/3 of Bobbiligam Grampanchayat, Shabad Mandal, Ranga Reddy District, which is the only source of ingress and egress of agricultural lands of Bobbiligam Grampanchayat, and take appropriate action on those persons, who illegally damaged and blocked the said public road. But in vain.

8. Under those circumstances, my client filed W.P.No.36043/2024 to direct you to restore the public road and take appropriate action on the persons, who illegally damaged and blocked the public road. The Hon'ble Court by orders dt.28.02.2024 disposed of the said writ petition directing you to directing you to consider the representation submitted by my client on 23.10.2020 and pass appropriate orders in accordance with law, within a period of eight (8) weeks from the date of receipt of a copy of the order.

9. Though, the Hon'ble High Court dispatched the said order copy on 24.3.2024 to you, till date, you did not take any action to comply with the said order. Therefore, you are hereby called upon to forthwith implement orders dt.28.2.2024 in W.P.No.36043/2021 passed by the Hon'ble High Court of Telangana by considering my client's representation dt.23.10.2020, otherwise, my client will be constrained to initiate contempt proceedings against you under the Contempt of Courts Act. A copy of the orders dt.28.02.2024 in W.P.No.36043/2021, a copy of the Representation dt.23.10.2020 and a copy of the affidavit filed in support of the above writ petition are annexed herewith for your perusal and appropriate action.
