Sub: Hon'ble High Court of Telangana–W.P.No.20915/2025–Interim Order granted - Ordered Notice -Personal Notice Permitted-Regarding.

1. You are hereby informed that W.P. No.621 of 2026 was filed by my client K Sreenu, S/o K Veeraswamy, challenging the Memo No CEHRD and Trg /GMAdm/ASEstt/POB/JP0 H/30/252 dt.10.7.2025 whereby Respondents 2 and 3 are taking steps to promote the enlisted AEs including the Unofficial Respondents who are juniors to the Petitioners without considering the cases of the Petitioners for promotion and without revising the Final Seniority list of Assistant Engineers communicated vide Memo No CGMHRD/GMAdm /AsEstt/P0 BM D2/373/20165 dt 9 2 2017 as illegal, unjust, arbitrary and unconstitutional and for consequential reliefs.

2. The said Writ Petition was listed before the Hon'ble High Court on 27.02.2026, and upon hearing the arguments and perusing the material papers, the Hon'ble Court was pleased to grant an interim order and the Operative portion of the order reads as follows:

“Instead of complying with the said directions, the 5th Respondent has once again directed the issue of title by issuing the impugned notice, declaring an extent of Ac.0801 cents in favour of the unofficial respondents and deleting the names of the Petitioner from Khata No.1376.

Considering the said submission and upon perusal of the orders passed by the Revenue Divisional Officer, the impugned notice dt.27.12.2025 is clearly contrary to the directions issued therein.

Accordingly, the impugned notice dt.27.12.2025 is hereby suspended, and any consequential proceedings, shall remain in abeyance.”

3. Apart from granting this interim order, the Hon'ble Court also ordered notice to you and permitted me to serve personal notice, while directing the Registry to list the Writ Petition after 4 weeks.

4. Therefore, as per the directions of the Hon'ble High Court, I hereby issue this personal notice informing you that W.P.No.621/2026 will be listed before the Hon'ble High Court as directed by the Hon'ble High Court either on 05.02.2026 or any other date and you have to appear before the Hon'ble High Court either in person or through your Counsel as and when the above writ petition is listed, failing which, W.P.No.621/2026, will be decided in your absence, based on the material available on record.
