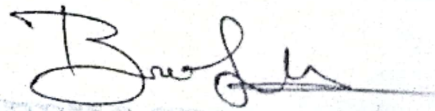

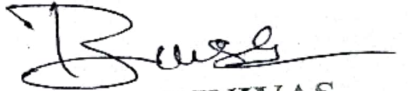


Learned counsel for the petitioners is permitted to take out personal notice to respondent No. 7 by way of Speed Post with Acknowledgment Due and file proof of service.
