Petition Under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate order or direction more particularly one in the nature of Writ of Mandamus declaring (i) the action of the Respondents 2 & 3 in rejecting the Petitioner's bid submitted for Sector -VI of Khammam District under the e-Tender Notice bearing Ref.No.MKTG/Paddy/Tenders/KMS 2026-27 as reflected in the 'Tender Stages View' updated on 18.03.2026 in the eGP Portal and also (ii) declaring the New Tender Notice dt.13.3.2026, as illegal, unjust, arbitrary, irrational, without jurisdiction, violative of Principles of Natural Justice, suffers from colourable exercise of power and in violation of Articles 14, 19 & 21 of the Constitution of India and consequently set aside the New Tender Notice dt.13.3.2026 to the extent of Sector-VI and direct the Respondents to treat the Petitioner's technical bid under the Tender Notice dt.25.2.2026 as valid and appoint it as transport contractor for Sector-VI if it becomes Ll under the said tender process;

Petition Under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to stay all further proceedings pursuant to e-Tender Notice bearing Ref.No.MKTG/ Paddy/Tenders/KMS 2026-27 dt.13.03.2026 issued by Respondents 2 & 3 to the extent of Sector-VI of Khammam District, pending disposal of WP.No.8684 of 2026, on the file of the High Court.
