LEGAL NOTICE/RPAD

Sir/Madam,

Under instructions from and on behalf of my client, Mr. Mr.Dhamiseti Sai Ranjith S/o.Janaki Ramayya, Aged about 28 years, R/o. H.No.2/67, Krapa, Mummidivaram, East Godavari District- 533216. (hereinafter referred to as “my client”), I hereby serve upon you the following legal notice:

My client advanced a sum of Rs. 1,00,000/- (Rupees One Lakh only) to you in the year 2022, in the presence of Mr. Manikanta who is friend of my client, as a friendly hand loan, upon your request and on your promise that you will return the said amount within a period of one year.

In acknowledgment of the above debt, you duly executed a promissory note in the year 2023 in favor of my client, wherein you agreed to repay the said amount, together with interest at the rate of 18% per annum, within the period agreed.

Despite repeated demands from my client, you have failed and neglected to repay the said amount and interest, and have instead refused to return the same in violation of the agreed terms.

Furthermore, my client instructs me that you have resorted to criminal intimidation by threatening to kill him and to file false complaints against him in case further demands for repayment are made. This conduct amounts to breach of trust and constitutes offences punishable under Indian Criminal Law and other laws of India. By this notice, I call upon you to repay the hand loan amount of Rs. 1,00,000/- along with interest at 18% per annum from the date of the hand loan, within 15 (fifteen) days from receipt of this notice, and to immediately cease and desist from making any kind of threats, intimidation, or filing false complaints against my client. Please take notice that abstaining from repayment or continuing any threats or intimidation shall compel my client to initiate appropriate civil and criminal proceedings against you at your own risk as to costs and consequences.

If you fail to comply with the above within the stipulated time, my client shall be constrained to initiate recovery proceedings against you in the competent court of law for recovery of the said amount with interest, as well as initiate criminal proceedings for intimidation and threats as per the applicable provisions of law. All costs and consequences thereof shall be to your account.

This notice is being sent to you without prejudice to all other rights available to my client under law and in equity.

You are, therefore, advised to act accordingly to avoid further legal complications.
