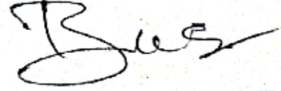

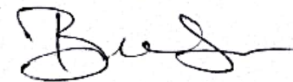
To issue a Writ of Mandamus declaring the inaction of the 2nd Respondent District Collector against the officials, including the 6th Respondent, regarding the illegal construction and encroachment of Road/Public Drain/Government lands in Sy.No. 53/1A of Tunkimetla Village by the 7th Respondent as illegal and unconstitutional.

Consequently, to direct the District Collector to take appropriate action on said illegal constructions and against responsible officials.

2. The said writ petition was listed for admission on **24.04.2026** before the Hon'ble High Court for the State of Telangana. After hearing arguments, the Hon'ble Court was pleased to grant an **Interim Direction** to respondent No. 6 to forthwith stop the unauthorized construction activity undertaken by respondent No. 7 on the public road/Government land in Survey No. 53/1A, situated at Tunkimetla Village, Bomraspet Mandal, Vikarabad District. The matter is posted to **12.06.2026**.
3. On instructions of my client, you are hereby requested to implement the interim orders of the Hon'ble High Court dt. **24.04.2026** passed in W.P. No. 13010/2026 without any deviation.
4. In view of the urgency, this notice is being sent to your official Email ID/Address to ensure immediate compliance with the court's direction to stop the unauthorized construction.
