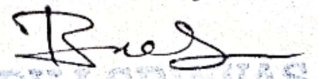

1. It is to inform you that Writ Petition No. 13010 of 2026 was filed by my client **Mrs. Balla Laxmi**, W/o. Balla Bichaiah, on the file of the Hon'ble High Court for the State of Telangana for the following relief: To issue a Writ of Mandamus declaring the inaction of the District Collector, Vikarabad, against illegal construction and encroachment of Road/Public Drain/Government lands in Sy.No.53/1A of Tunkimetla Village as illegal and unconstitutional, and to direct appropriate action against the responsible officials and the said illegal construction.
2. After hearing the said Writ Petition at the admission stage, the Hon'ble High Court was pleased to grant the following interim order on **24.04.2026**:
 - Learned counsel for the petitioner is permitted to take out personal notice to respondent No. 7 and file proof of service by the next date of hearing.
 - There shall be an interim direction to respondent No. 6 to forthwith stop the unauthorized construction activity undertaken by

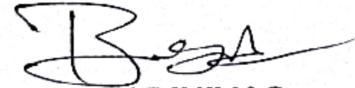
