**PETITION UNDER SECTION 528 BNSS TO QUASH THE
PROCEEDINGS**

BRIEF FACTS OF THE CASE

The present petition arises out of Crime No. 249/2024, registered at Abid Road PS, Hyderabad, for offences under Sections 318(4), 319(2) BNS and Section 179(1), 80(A)/177 MV Act. The case concerns alleged fraudulent procurement of an MLA car sticker and fake vehicle number by Accused-1 and Accused-2. The charge sheet mentions Petitioner (Sai Kiran A-3) only as an acquaintance and Data Entry Operator in the Assembly, without any evidence of introducing or helping anyone to acquire the sticker. Petitioner neither has authority nor participated in the procurement or issuance of the sticker. There are no specific contentions or allegations supported by documents or witness statements against Sai Kiran A-3.

GROUND FOR QUASHING:

- i. No direct allegations, evidence, or witness statements that Sai Kiran A-3 introduced or helped Accused-1 or Accused-2 in procuring the sticker.
- ii. Petitioner is not the issuing authority and was not involved in any criminal act regarding the sticker or number plate.
- iii. Continuation of proceedings would amount to abuse of legal process since there is no material that establishes criminal intent, abetment, or conspiracy on Sai Kiran's part. Other grounds will be argued during the hearing of the Case.
- iv. Supreme Court precedent (Dara Lakshmi Narayana & Ors v. State of Telangana) supports the quashing of proceedings based on vague, omnibus, and unsupported allegations.

PRAYER

- (a) Quash the proceedings in C.C.No. 255 of 2024 on the file of the II Addl. Chief Judicial Magistrate at Nampally, Hyderabad (Crime No. 249/2024: Abid Road PS) in respect of Petitioner/Accused-3 Sai Kiran.
- (b) Stay all further proceedings including appearance of the Petitioner in C.C.No. 255 of 2024, pending disposal of this petition.
- (c) Dispense with the filing of a certified copy of C.C.No. 255 of 2024 for the purpose of this petition.
- (d) Pass such other order or orders as may be deemed fit and proper in the interests of justice.
