Subject: Legal Notice for Misconduct, Defamation, and Damage
to Institutional Reputation

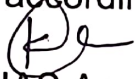
Under instructions from and on behalf of my client EKAM IAS Academy represented by Sreelekha Abburi Founder / Director, having its premises at RTC X Roads, Hyderabad, I hereby address you as follows:

1. That you had enrolled as a student at EKAM IAS Academy under Enrolment No. 1124110025, having joined the UPSC CSE (GS + Optional) course in August 2024. That soon after your admission, it was observed and reported that your behavior and attitude was highly inappropriate, particularly in your interactions with female students. Multiple complaints were received regarding your conduct which was unbecoming of a student of a reputed institution.
2. That, in addition to the above, you were also found to have morphed videos of faculty members and were involved in spreading false and malicious propaganda against the Academy, its faculty, and its operations, both within and outside the campus, thereby vitiating the

academic environment and disturbing the peaceful atmosphere of the institution.

3. That on account of your misconduct and in the interest of maintaining discipline and safety within the Academy, your parents were called to the institution and made aware of your attitude and behavior. Upon being informed, your parents requested the Academy not to take any harsh or legal action, pleading that the same may affect your career and future. Considering request of your parents, on humanitarian grounds and keeping in mind your age and future, the institution refrained from initiating any legal or criminal proceedings against you at the time, despite having sufficient grounds to do so.
4. However, it has recently come to the attention of the Academy that you are once again spreading false, defamatory, and baseless allegations against the institution with the malicious intent of damaging its hardearned reputation and goodwill in the educational field. Your acts of defamation and propaganda are highly condemnable and constitute serious civil and criminal wrongs, which are punishable under both Civil and Criminal laws and other applicable laws of India.
5. You are hereby called upon through this legal notice to immediately cease and desist from making any further false, derogatory, or defamatory statements against 'EKAM IAS Academy, its management, faculty, or its operations, in any form whatsoever whether oral, written, electronic, or digital.

6. You are further directed to tender a written apology along with video graphed apology through post/email/in-person within seven (07) days from the date of receipt of this notice, failing which, my client shall be constrained to initiate appropriate civil and criminal proceedings against you before competent courts of law for defamation, damages, and other reliefs, holding you solely liable for all costs, consequences, and repercussions thereof. This notice is issued to you without prejudice to any other legal rights, claims, or remedies available to my client under law and equity. You are advised to treat this matter with seriousness and act accordingly.
